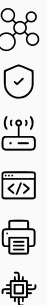

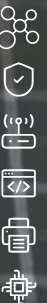

Application for Visa

Represent you with the Home Office up until the decision made on your application.

3

Prepare you for interview with the Home Office, when necessary or applicable.

Assist you with your relocation to the UK.

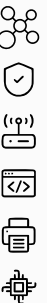

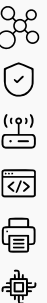
OUR FEES
